Appointment Retainer Agreement & Studio Policies

Version 1.0

Effective July 7, 2026

Purpose

Thank you for choosing to work with Sacred Rebel Tattoo.

Because each tattoo project is highly individualized and my appointment availability is intentionally limited, every confirmed appointment requires an Appointment Retainer.

An Appointment Retainer is **not a deposit** and **is not payment for tattoo services**. Rather, it is a separate agreement that compensates for the professional services rendered before your appointment, including consultation, communication, scheduling, project planning, administrative preparation, payment processing, and reserving exclusive appointment time that is no longer available to other clients.

Upon successful fulfillment of this Appointment Retainer Agreement, a portion of the Appointment Retainer is credited toward your original and mutually agreed-upon tattoo project.

1. Appointment Retainer Structure

The current Appointment Retainer is:

Appointment Retainer: \$110

Upon successful fulfillment of this Agreement:

Retainer Credit Applied Toward Tattoo: \$100

The remaining portion of the Appointment Retainer compensates for administrative preparation, scheduling, payment processing, and associated business expenses incurred in reserving your appointment.

Appointment Retainers are earned upon receipt.

2. Appointment Confirmation

An appointment is not considered reserved until:

- An appointment has been offered by Sacred Rebel Tattoo.
- The Appointment Retainer has been successfully received.
- The appointment has been manually confirmed by the artist.

Until all three conditions have been met, appointment availability remains subject to change.

3. Rescheduling

One complimentary reschedule may be requested with a minimum of forty-eight (48) hours' notice.

Subsequent rescheduling requests will result in a \$50 reduction of the available Retainer Credit.

Rescheduling more than twice requires a new Appointment Retainer.

Rescheduling requests must be submitted by email and confirmed by the artist.

4. Multi-Session Projects

Extensive or intricate tattoo projects may require multiple appointments to ensure both client safety and the highest quality artistic outcome.

For multi-session projects, the **\$100 Retainer Credit** remains associated with the original and mutually agreed-upon project and carries forward between sessions, provided the project remains active and in good standing.

A project is considered to remain in good standing when the next appointment is scheduled within **ninety (90) days** of the initial appointment or the most recent tattoo session.

If more than **ninety (90) days** pass without scheduling the next appointment, the project will be considered inactive. The original Retainer Credit will be forfeited, and a new Appointment Retainer will be required before additional appointments may be scheduled.

Exceptions to this policy may be granted only with prior written approval from Sacred Rebel Tattoo, based on circumstances evaluated at the artist's sole discretion.

5. Nonrefundable & Nontransferable

Appointment Retainers are nonrefundable.

Appointment Retainers are also nontransferable between:

- Individuals
- Tattoo projects
- Appointment dates outside approved rescheduling
- Tattoo credits
- Cash or other forms of compensation

Significant changes to the agreed-upon project may require a new Appointment Retainer.

Appointment Retainers expire ninety (90) days from the original booking date unless the project is actively ongoing and in good standing.

6. Client Cancellation

Cancellation by the client does not alter the nonrefundable nature of the Appointment Retainer.

Should rescheduling not be reasonably accommodated, the Appointment Retainer remains forfeited.

7. Travel

Clients traveling from outside the local area acknowledge that tattoo appointments require flexibility.

Sacred Rebel Tattoo is not responsible for airfare, lodging, transportation, lost wages, travel delays, weather events, or other travel-related expenses.

Completion of larger projects during a single appointment cannot be guaranteed.

8. Artist Availability

While every reasonable effort will be made to honor all scheduled appointments, tattooing is a physically demanding profession and unforeseen circumstances occasionally arise.

Should an appointment require postponement due to illness, injury, emergency, equipment failure, or circumstances beyond the artist's reasonable control, every reasonable effort will be made to reschedule the appointment.

The nonrefundable nature of the Appointment Retainer remains unchanged.

9. Payment Disputes

Clients agree to contact Sacred Rebel Tattoo directly regarding any concerns before initiating a payment dispute or chargeback.

Initiating a chargeback does not invalidate this Agreement.

Sacred Rebel Tattoo reserves the right to pursue recovery of any Appointment Retainer, associated processing fees, administrative expenses, penalties, collection costs, or other damages permitted by applicable law.

Clients who initiate payment disputes or repeatedly violate studio policies may be refused future services.

10. Acceptance of Agreement

By submitting payment for an Appointment Retainer, the client acknowledges that they have:

- Read this Appointment Retainer Agreement & Studio Policies.
- Had the opportunity to ask questions before submitting payment.
- Understood and voluntarily accepted these terms.
- Agreed that the Appointment Retainer is earned upon receipt and is not payment for tattoo services.

Submission of an Appointment Retainer constitutes acceptance of this Agreement in its entirety.
